



### FUND DESCRIPTION

FTSE ADS Saudi Minimum Variance Fund is an open-ended public fund, solely invested in companies listed on the Tadawul/Saudi Stock Exchange of The Kingdom of Saudi Arabia ("KSA"). The fund seeks to target a risk adjusted market return in the medium to long term through a smart beta strategy. The fund seeks to capture consistent market risk premium by reducing the volatility of the relevant index based on historical return information, thereby improving the risk-return trade-off, while maintaining full allocation to the relevant equity market. The funds aims to reduce volatility by applying a transparent rules-based approach that minimizes historical variance subject to additional constraints on the weight of individual stocks, industries and other market related optimizations that may be carried out from time to time, to achieve the fund objective.

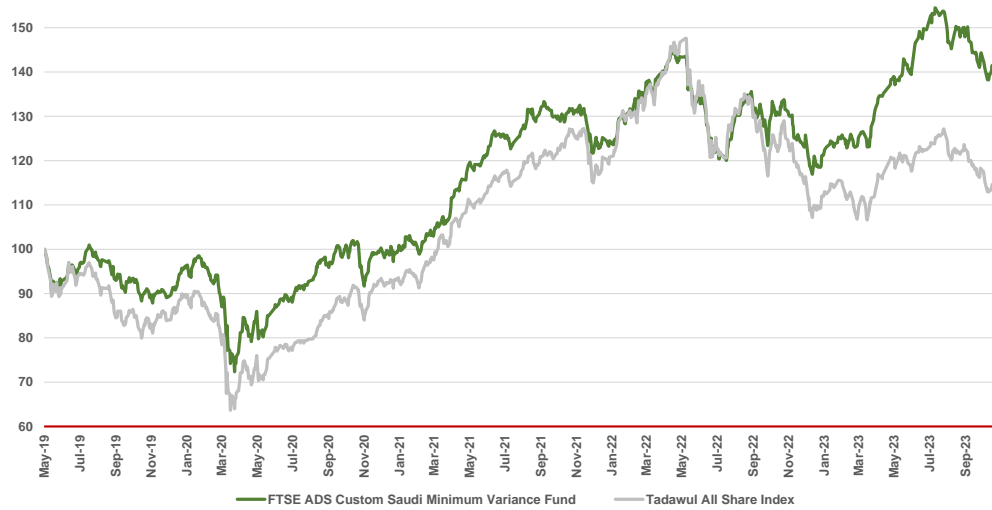

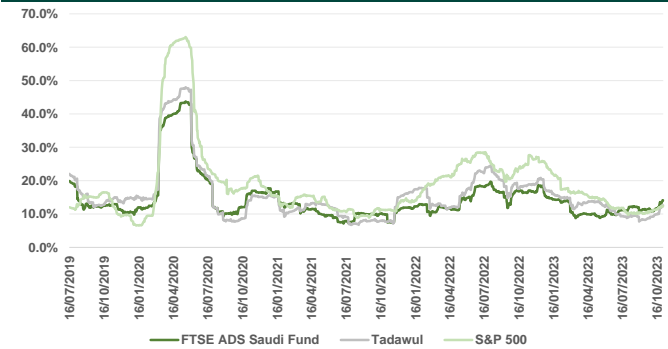

### Fund's Standard Deviation (3 month rolling)

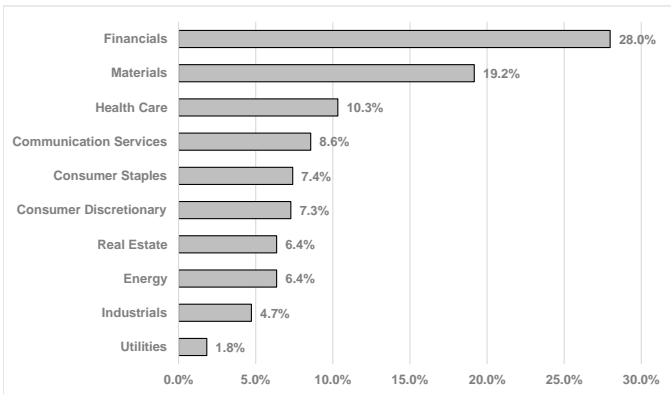


### Fund's Correlation with the S&P 500 (3 month rolling)

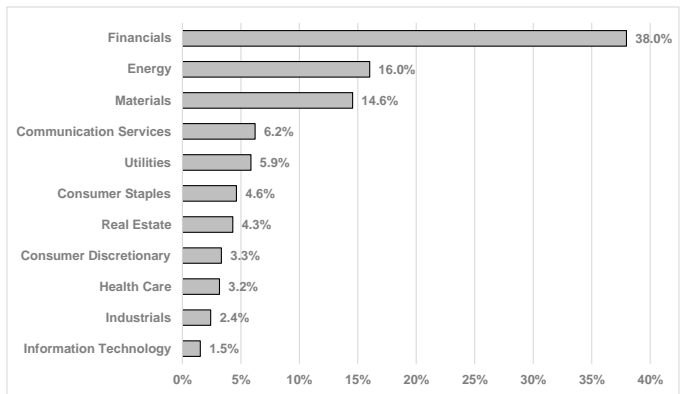
